Match was on April  $15^{\text{th}}$ . We had 12 shooters. Nell Roberts won with a 92x and Dave Jenness finished  $2^{\text{nd}}$  with a 74x.

We shoot at 25 and 50 yards, one handed, and accuracy is the main thing that is stressed – speed will come along. We shoot .22 caliber, center fire (.32 caliber or larger), and .45 caliber so you would need about 100 rounds of each caliber. 2700 Pistol matches, an NRA approved aggregate pistol match, are held the third Saturday of each month from February through November, with registration starting at 8:30 AM, and shooting starting at 9:00 AM. The match fee for a regular match is \$25. You do not have to shoot all 3 parts (.22LR, centerfire, and .45) of the 2700 course in order to compete with the group (\$10 fee for each part).

**LEGISLATIVE LIAISON:** Patrick Nolan, <u>pnolan747@gmail.com</u>, 803-318-1400. Patrick Nolan reported:

*No gun bills will be passed by the legislature this year.* The four bills that crossed from the house to the Senate – **H3420 H3429 H3566** and **H3930** – do not have time to pass the Senate this year, but can be acted on in the second year of this session (2018). The Senate passed no gun laws this year.

#### Worth noting:

**H3240** "National Reciprocity" (really "recognition") Passed the House 85-23 on 5/4 and sent to the Senate; sent to Judiciary on 5/8.

**H3429** Allows guns with an aggregate value of \$3,000 to be exempted from bankruptcy. Passed the House on 2/16, was introduced in the Senate 2/21, and passed out of Judiciary subcommittee and Judiciary Committee on 5/3.

**H3566** Training for first responders to carry in schools. Passed the House 101-0 on 4/6/17, sent to Senate and referred to Judiciary on 4/11.

H3930 After passing the House, was assigned to Senate Judiciary, but did not get on this year's agenda.

**S430** No transfer of firearms or ammo if one knows the receiver is a prohibited person. Passed out of Judiciary subcommittee.

**S449** (similar to **H3700** and **H3930**) "Constitutional Carry," Passed out of the last meeting of the Judiciary subcommittee 3-1; too late for further Senate action this year.

**S055** and **H3571**, The so-called "gag rules" you may have heard of, have not moved anywhere since being introduced in January.

Time, location: 8 a.m. to 5:30 in the MCRC classroom with about an hour in the Qualification Bay. Cost: \$65 for MCRC members. (Non-members: \$80.) Bring ear protection, eye protection, a handgun that functions well, 50 rounds of factory ammunition (NO homemade reloads), a strong-side belt holster, and a sturdy belt.
