The Match Results:

Overall Match Winner/ 1st Master: Clay Marshall shooting a score of 484-17X. Clay takes a commanding lead in the 2017 overall Match winner race!

2nd Place and 1st Expert: Scott Johnson with a final score of 466-9X. Scott keeps knocking on the door of the Master Score just missing again today. I am betting it breaks it down the next match.

3rd Place and 1st Master Unclassified: Jay Miller shooting 416-1X. Great score for his first match back in competition.

Thanks to all who attended. Thanks for helping set up and put things away. The Shooters make these match's happen and I cannot thank you enough. We are looking forward to seeing EVERYONE Sunday February 12th for our 2nd Match of 2017. Will Clay be able to back up his Win in February?? Come out, bring another shooter and give him some competition.

HIGHPOWER/TACTICAL RIFLE matches are conducted at MCRC on the second Sunday of each month. The match is held on the Hathcock range, with targets at 200 yards and starts at 9:00am and usually ends around 12:00pm.

The course of fire is ten (10) rounds slow fire standing, ten (10) rounds rapid fire sitting with one reload required, ten(10) rounds rapid fire prone with reload and twenty (20) rounds slow fire from the prone position, for a total of 50 rounds for score. There is a 5 minute preparation period before each course of fire and sighter shots maybe made.

Highpower / Tactical rifle is a good opportunity to learn rifle marksmanship and position shooting while getting instruction from master level competitors. All you need to bring to the match is a rifle, about sixty (60) rounds of ammunition and have a fun time. The primary rifle for the match is the AR family of rifle, while many other rifles are used such as the M1A, Grand, 1903s, bolt rifles that can be reloaded quickly, or other magazine fed rifles. Highpower is also a very good opportunity for NEW AR owners to learn about their rifle, care, maintenance, use, as certified instructors are at the match and competitors who have shooting the AR for as long as the AR has been around.

Tactical Rifle: These AR rifles will be configured so as to replicate as closely as possible the tactical rifles (semi-automatic) and equipment used by the United States Military and America's Law Enforcement Community in "mid-range" tactical applications. These semi-automatic rifles will be more "off the rack" or "stock" than "competition" in nature. They will be more of a "tactical design" than "match design" and therefore less expensive than the vast majority of mid-range rifles currently in use. Optics maybe used, as are bi-pods and slings.

NCOWS uses rules similar to SASS Cowboy matches, but the requirements for weapons and clothing require greater accuracy and attention to period-correct details. There are 2, 3, and 4 gun classes, so anyone with a pre-1900 pistol and lever action rifle, or pistol and shotgun, can participate. The guns can be originals or reproductions, smokeless or black powder. New participants can come as they are, since we realize it takes a long time to acquire the needed clothing and accouterments. Gun carts are optional. There is no overall winner in NCOWS; each class is judged independently. There are 12 available classes.

We shoot at 25 and 50 yards, one handed, and accuracy is the main thing that is stressed – speed will come along. We shoot .22 caliber, center fire (.32 caliber or larger), and .45 caliber so you would need about 100 rounds of each caliber. 2700 Pistol matches, an NRA approved aggregate pistol match, are held the third Saturday of each month from February through November, with

registration starting at 8:30 AM, and shooting starting at 9:00 AM. The match fee for a regular match is \$25. You do not have to shoot all 3 parts (.22LR, centerfire, and .45) of the 2700 course in order to compete with the group (\$10 fee for each part).

H3052 (Putnam) see also S085

Jacob Hall's Law (see also H3330)

Amends section 16-23-431 to authorize school employees to hold a "Public School Concealed Weapons Permit" to authorize school employees to respond to imminent threats. Additional training required and not subject to FOIA requests on holders of such permits.

H3174 (Allison, Magnuson)

Amend section 23-31-240

To add victim advocates employed by a law enforcement agency to carry in pursuit of their duties.

H3180 (Cobb-Hunter) See also S143

Amend 23-31-70

A firearm cannot be delivered to a purchaser *or transferee* until a NICS is performed by a *licensed dealer* who has received a completed a check and it is known that the person is not known not to be prohibited.

H3181 (Cobb-Hunter)

Very confusing Bill for a non-lawyer.

Would require background checks at ALL gun show sales. May not sell, exchange, or transfer without a BG check and approval of SLED. Exception for immediate family: spouses, domestic partners, children, and step children.

H3182 (Crosby)

Increases penalty for violation of 16-23-20 unlawful carry to \$10,000, 5 years, or both.

H3183 (Gilliard) Assault Weapons

Definition of Assault Weapon:

Any weapon having ANY one or More of the following:

- (a) Semi-auto centerfire rifle with a detachable magazine with capacity of 21 or more rounds
- (b) Semi-auto shotgun with foldable stock, or magazine capacity of more than 6 rounds
- (c) Any firearm so modified

(d) Anyone possessing such parts can easily assemble such a weapon

Mere possession of a machine gun or assault weapon is a crime.

It is, also, unlawful to sell or give a weapon to someone WHOSE NAME is on the terrorist watch list!

H3187 (Burns, Chumley, and Long)

Amends 16-23-20 to add (17) EMTS, Firefighters, and other first responders who are trained as law enforcement officers, may carry concealed during emergency treatment/situations.

H3190 (Gilliard)

A bill to increase penalties for unlawful carry 16-23-20.

1st offense \$1,000, 1 year, or both.

2nd Felony \$2,000 no more than 5 years, or both,

H3191 (Gilliard)

Violation of 16-23-20 Graduated Penalties.

H3192 (Gilliard)

16-23-440 Unlawful firing into dwellings amended to add indoor/outdoor malls, movie theatres, parking lots or other places with 3 or more people assembled.

H3205 (Pope)

Amends section 23-31-240 to allow those *retired* from offices (judges, magistrates) listed to carry. Also adds clerks of courts to list.

H3212 (Rutherford)

Amend 16-11-46 To allow Immediate appeal of immunity denial from prosecution vis Protection of Persons and Property.

H3217 (Putnam)

“Lucy’s Law”

Adds 16-23-540 Requires report of loss of a lawfully owned firearm, rifle, or shotgun *within 24 hours of discovery* along with serial number, make, model, caliber, and distinguishing marks or numbers.

1st offense \$100, 2nd \$200, 3rd and subsequent \$500-\$1000 and 3 years, prohibition from owning such weapon for 3 years.

H3239 (Cumley, Burns, and Long) See also S088

Amends 23-31-220 to create a cause of action for a CWP if their employer prohibits concealed carry and employee is injured in a crime on the property

H3240 37 (*Sponsors*)

In order to pave the way for a “National Reciprocity Act,” SC will *recognize* permits from *ALL* other states.

H3248 (Fry and Crawford)

Removes restrictions on CWP's in Post-Secondary educational institutions. Requires those institutions to develop policies and procedures to implement this sub-section.

H3252 (Gilliard)

Make unlawful the use, transport, manufacture, possession, distribution, or sale of GREEN TIP AMMUNITION!

H3265 (McKnight)

Law Enforcement Agencies may not use unmanned drones with firearms. This does not apply to vehicles used to detonate/disarm explosives. Penalty: felony 5 years

H3266 (Mcknight, Cobb-Hunter)

Unlawful to provide a weapon to someone whose name appears on a terrorist watch list. See also H3183

H3330 (Hill)

“Jacob Hill’s Law”

School Officials made decide to:

- (a) Allow school personnel with CWPs to carry in schools
- (b) Require more training for SP with CWPs to carry
- (c) Prohibit SP with CWPs from carrying

S0021 (Campsen)

Adds section 50-11-108 permits killing of wild or domestic animal in any season in self-defense. If it is a big game animal, shooter must not keep the carcass. Must be reported to DNR.

S0085 (Bryant) see also H3052 and H3330 for other versions. A Jacob’s Hall Law to allow school personnel, after additional training to carry in schools

S0088 (Verdin)

Amend 23-31-220 to create cause of action for a CWP holder whose employer prohibits concealed carry is injured in a crime on the prohibited property (see also H3239).

Amends 16-23-20 to allow ANYONE to carry a concealed weapon during a mandatory evacuation.

Amends article 4 section 31 title 23 to institute an “Institutional CWP” (with additional training) to allow its holder to carry in schools, daycares, churches, and hospitals.

Amends section 56-3-1230 to REQUIRE THE DMV TO AFFIX A STICKER TO THE LICENSE PLATE OF A VEHICLE OWNER WITH A CWP INDICATING THEY HAVE A CWP!

S0143 (McLeod) see H3180.

S0158 (Malloy)

Amends 16-23-910 To require 28 days for a NICs completion (not 3). Different from S0143 (16-23b920) in that it ONLY applies to NICS requests by a licensed firearms dealer (not other exchanges and transfers).

S0159 (Malloy)

Amends 23-31 1120, 1130 extends NICs from 3 to 28 days
