Roy Mullis called the meeting to order and led the club in reciting the Pledge of Allegiance. He also led the club in a prayer. The minutes of the January meeting were approved by voice vote.

**PRESIDENT'S REPORT:** Roy Mullis, <u>roym788@pbtcomm.net</u>, 803-360-1490 Roy Mullis reported.

This has not been a good month. Since the last meeting, we have experienced a lot of violations of range rules. Not wearing safety glasses, shooting at targets in the plate bay other than the plate rack, members not supervising visitors and bullets hitting the ground. Range rules are clear. Safety glasses will be worn on all ranges. No other targets are allowed in the plate bay. Members must supervise their guests at all times. Guests could be a family member or a friend. Bullets must not hit the ground. PERIOD. I was away from the range a couple of weeks ago on a Sunday. When I returned to the range Monday, I found 41 bullet impacts on the Hathcock range. This is a warning to

all. We are investigating security cameras for the Hathcock range. I am looking at systems and getting prices. If this continues to happen, the club will install a surveillance system. If the club has to put cameras in all the bays to protect the club, you can be assured that dues will rise.

I called a meeting of the Executive Committee to make sure all the committee understood the situation involving the club websites and the database. The committee voted to drop the member's services site. If you need to know anything about your membership, change anything on your profile, or look up how many credits you have, you will have to contact Linda for that information. The committee wants everyone to understand that before Stephen became VP and built the member's services site, no one had access to that information. Members will need to keep their information updated because that's where the email addresses are stored for sending out renewal notices. I have had members tell me about not getting renewal notices and most of the time when we check, their email has not been kept up to date.

Patten is sending out renewal letters. Ultimately it is the responsibility of the member to keep up with their membership. If you have not renewed lately you may have the old card with the expiration date on the back. The new card has the expiration date on the front. Although we have made great progress in speeding up renewals, I advise members to get their renewals in at least a month in advance.

**HIGH POWER RIFLE:** Clay Marshall, <u>marshall@bellsouth.net</u>, 803-422-7072 or Chuck McMenamy, <u>cmcmenamy@sc.rr.com</u>, Cell: 803-467-8272 and Home 803-708-4306 Chuck McMenamy reported.

We had the best turnout of the year. Our match winner was Maurice Huffman with a 487 15x, 2<sup>nd</sup> Scott Johnson with a 469 8x, 3<sup>rd</sup> Jay Miller with a 468 11x, and 4<sup>th</sup> Joseph Hodge with a 462 9x.

HIGHPOWER/TACTICAL RIFLE matches are conducted at MCRC on the second Sunday of each month. The match is held on the Hathcock range, with targets at 200 yards and starts at 9:00am and usually ends around 12:00pm.

The course of fire is ten (10) rounds slow fire standing, ten (10) rounds rapid fire sitting with one reload required, ten(10) rounds rapid fire prone with reload and twenty (20) rounds slow fire from the prone position, for a total of 50 rounds for score. There is a 5 minute preparation period before each course of fire and sighter shots maybe made.

Highpower / Tactical rifle is a good opportunity to learn rifle marksmanship and position shooting while getting instruction from master level competitors. All you need to bring to the match is a rifle, about sixty (60) rounds of ammunition and have a fun time. The primary rifle for the match is the AR family of rifle, while many other rifles are used such as the M1A, Grand, 1903s, bolt rifles that can be reloaded quickly, or other magazine fed rifles. Highpower is also a very good opportunity for NEW AR owners to learn about their rifle, care, maintenance, use, as certified instructors are at the match and competitors who have shooting the AR for as long as the AR has been around.

Tactical Rifle: These AR rifles will be configured so as to replicate as closely as possible the tactical rifles (semi-automatic) and equipment used by the United States Military and America's Law Enforcement Community in "mid-range" tactical applications. These semi-automatic rifles will be more "off the rack" or "stock" than "competition" in nature. They will be more of a "tactical design" than "match design" and therefore less expensive than the vast majority of mid-range rifles currently in use. Optics maybe used, as are bi-pods and slings.

We use the A-31 target for the regular match, and the A-51 target for those "prone" only shooters.

Participants must use period type rifles and sights of 1895 and earlier. Period dress is welcome. Cast lead bullets only. No gas checks allowed. There will be 3 categories: Standing, Standing Supported and Sitting Supported. Entry fees is \$5.00 for each category or \$10.00 for all three. All targets will be engaged at 200 and 100 yards, with five shots on each of three targets. Winner of each category will be the best of 15 shots. Grand Aggregate will be awarded also. Participants may have unlimited sighter shots during a relay on the sighter gong. Current info, scores and pictures can be found on the MCRC web site.

NATIONAL CONGRESS OF OLD WEST SHOOTISTS (NCOWS): Dave Graley, <a href="mailto:dlgraley@aol.com">dlgraley@aol.com</a>, 803-419-2772 – Saluda Saddle Tramps is the South Carolina posse of NCOWS. Dave Graley reported:

NCOWS is all about the Old West between 1865 and 1899. We call our matches, held in the Cooper Bays, western action shooting, since few of us actually portray a cowboy. We are sticklers for authenticity in our firearms, clothing and accoutrements, but give new members 18 months to build their kit. We usually shoot 5 stages. Our matches are laid back, and we spend just as much time chiding each other as we do shooting. Although original guns occasionally appear, reproductions by Uberti, Pietta, Chiappa, Henry, and Armi San Marco are the norm.

There is an annual convention, as well as a national match and regional matches. The convention this year is in Davenport, Iowa, on March 24-26. A very popular part of the convention occurs on Friday night, when the National Congress of Old Whiskey Samplers convenes their meeting.

Our next match is on February 26. Please come check us out and have a cup of coffee.

Check out NCOWS at <a href="www.ncows.org">www.ncows.org</a>. Match fee is \$16.00. If anyone just wants to check us out, please stop by. If anyone has an interest, please contact Dave Graley, aka Okefinokee Outlaw.

NCOWS uses rules similar to SASS Cowboy matches, but the requirements for weapons and clothing require greater accuracy and attention to period-correct details. There are 2, 3, and 4 gun classes, so anyone with a pre-1900 pistol and lever action rifle, or pistol and shotgun, can participate. The guns can be originals or reproductions, smokeless or black powder. New

participants can come as they are, since we realize it takes a long time to acquire the needed clothing and accounterments. Gun carts are optional. There is no overall winner in NCOWS; each class is judged independently. There are 12 available classes.

There have been 2 matches since our last meeting. Our January match was the biggest regular monthly match for MCRC USPSA ever with 82 shooters competing. The January match was a special classifier match, to give shooters an opportunity to earn a new classification or upgrade an existing one. Jack Suber of MCRC was the top Open division shooter and Weston Land was the high Limited division shooter. The high shooter in Limited 10 division was Glenn Allan from Simpsonville. Juniors are free. New shooters are half price (\$8). Set-up for the match is on the preceding day on Friday afternoon. If you are interested in coming out and trying a shooting sport that involves running and gunning, you can start with very nearly any centerfire pistol if you have enough magazines for it.

Our first match of 2017 will be February 18, 2017.

We shoot at 25 and 50 yards, one handed, and accuracy is the main thing that is stressed – speed will come along. We shoot .22 caliber, center fire (.32 caliber or larger), and .45 caliber so you would need about 100 rounds of each caliber. 2700 Pistol matches, an NRA approved aggregate pistol match, are held the third Saturday of each month from February through November, with registration starting at 8:30 AM, and shooting starting at 9:00 AM. The match fee for a regular

match is \$25. You do not have to shoot all 3 parts (.22LR, centerfire, and .45) of the 2700 course in order to compete with the group (\$10 fee for each part).

Black Powder Muzzleloaders shoot the 4<sup>th</sup> Saturday of the month, from 9:00am until about 12:00pm, except during Deer season when we turn Southern and head for the woods!! The group usually uses paper targets, and follows muzzleloader rules, but they have a lot of fun elements in every match and also host a few novelty matches each year. Round ball with any type of black powder is acceptable, and you can shoot in-lines. They use the silhouette range primarily, and shoot at distances of 25 - 50 - 75 - 100 yards.

**LEGISLATIVE LIAISON:** Patrick Nolan, <u>pnolan@gmail.com</u>, 803-318-1400. Patrick Nolan reported:

### The Constitutional Laws subcommittee of the SC House Judiciary Committee convened shortly after 9:00 AM on Thursday January 26.

There were three bills on the agenda: (1) H3352 on FOIA, (2) H3240 on National CWP "Reciprocity," and (3) H3333 on Indigent Defense. The first devolved into a detailed discussion of "fee schedules" for fulfilling FOIA requests. After discussion a favorable recommendation was voted.

Representative Clemmons then presented the outlines of H 3240, which in, my opinion, is really a "recognition," not a "reciprocity" bill. SC would recognize the concealed weapons permits of all other states, in (my words) the hope that other states (perhaps nationally) would recognize ours.

There was a brief questioning about the differences between this bill and "constitutional open and concealed carry." Representative Clemmons explained that this bill neither expander nor constricted current SC rights. Representative James Smith extensively challenged the bill on two grounds (1) it

would allow people from states that don't require training to carry in SC, and (2) it would make SC citizens "second class citizens" because people from other states would not have to meet the same criteria as SC citizens to carry in SC. His example was that Alabama allows 18 year olds (the federal standard for ownership of handguns) to get permits, but SC requires CWP applicants to be 21, and many states (e.g., Georgia, and Vermont, my examples) do not require "training." The fact that SC recognized Georgia's permits in recent legislation was dismissed by Rep. Smith because they are a "border state," and the argument, by Clemmons, that we recognize other states' driver's licenses, was dismissed by Rep. Smith because we don't accept all permits by other states (my example, cosmetologists). My comment: ignoring the fact that the 2nd amendment, unlike cosmetology, is an enumerated Constitutional right.

Under House rule, the subcommittee had to suspend the hearing once the House was in session. Therefore the hearing was stopped and no vote was taken on a favorable report, at about 10:15. If memory serves, research has shown that having a training requirement has no measurable effect on CWP safety. I am trying to find references to that research – any help would be gratefully accepted!

## The Constitutional Laws subcommittee of the SC House Judiciary Committee reconvened on February 8, 2017 to further consider H 3240.

The meeting was scheduled on short notice and began before its expected time of 1:00PM (because the house had adjourned early). I missed the first 15-20 minutes including comments from the assembled red t-shirt clad "Moms Demand Action SC" who spoke against it. A SLED spokesperson (I am seeking his name, Adam?) reported statistics on the number of permit holders in 2016 (~300,000) and the number of "revocations" that year, 505. Since SLED does not track the reasons for "revocations," it includes people who voluntarily surrendered their permits because they were moving out of state together with persons who were arrested for various reasons. Upon questioning, he indicated that SLED favors the training requirement, so it opposed the bill. Jarrod Bruder, Executive Director of the SC Sheriffs' Association, also spoke in favor of training and against the bill. Tony Roulette, State Liaison NRA ILA, spoke in favor of the bill.

One interesting issue arose in the discussion; Rep. Smith was concerned that recognizing all other state's permits would allow 18-year-old CWP holders (e.g., from Alabama) to carry concealed in SC whereas 18 year old SC residents were not eligible for permits and could not. (Recall his "second class citizens" comment in the earlier session.) An amendment to only allow out of state permit holders 21 or older was suggested. The SLED spokesman indicated that he believed that SLED now had that requirement for some reciprocal states. Indeed, from SLED's website, see italics:

<u>Alaska, Arizona, Arkansas, Florida, Georgia, Idaho</u> (Enhanced only), Kansas, Kentucky, <u>Louisiana, Michigan, Mississippi</u>(Enhanced Only), <u>Missouri, New Mexico, North Carolina, North Dakota</u>(Enhanced Only), <u>Ohio, Oklahoma, South Dakota</u>(Enhanced Only), <u>Texas, Tennessee</u>, <u>Virginia</u>, <u>West Virginia</u> (*21 years of age and older*) and <u>Wyoming</u>.

However, Rep. Delleney questioned the constitutionality of excluding 18-20 olds. (PDN: In 2008, the SC Supreme Court ruled that, with the exception of alcohol, the Constitution of SC grants full legal rights to anyone 18 years or older. You'll recall that this meant that 18 olds could legally own handguns, even though they could not purchase one from an FFL.) This ended discussion of the

amendment, but it does raise the issue of the SLED requirement noted above, and perhaps the legality of restricting SC CWPs to 21 and older.

A roll-call vote on giving the bill a "favorable" recommendation was held, and it passed 3-2. The full House Judiciary Committee will consider the bill on Tuesday, February 14, at 2:30 PM (or 1 ½ hours upon adjournment of the House) in RM 516 Blatt Building.
