Roy Mullis called the meeting to order and led the club in reciting the Pledge of Allegiance. He also led the club in a prayer. The minutes of the September meeting were approved by voice vote.

We have a lot to cover in his meeting.

Happy Columbus Day and Canadian Thanksgiving Day.

I am dismayed at the number of rules violations that have happened since our last meeting. Some we have caught happening others we have only found the evidence. In the plate bay there has been evidence of someone shooting a carbine. (blackened brass). I can't figure how anyone can think that a carbine qualifies as a handgun. I know some are thinking about it because Friday I was asked about

shooting an AR with a 9" barrel at the Plates. We have found brass as close as 7 yards from the plates. There is a 15 yd. minimum. Its marked by two posts. It can't be missed.

I recently had two members drive down the Hathcock range to put up targets. One excuse was "I haven't been here in a while. I didn't remember. Driving on that range hasn't been allowed since I started the grass. That's been 10 years or better.

There have been two incidences in the last week of bullets impacting the ground. The second instance was reported by the member who did it. It seems a suppressor came loose and bullets were hitting the baffles and deflecting down. He caught it and called me immediately. Of course one of the hoses was hit and we lost about half of it. The other instance happened the day before. I didn't see that one till the next morning but I remember who was there that day.

In the silhouette bay, we found where someone had been running up the range and shooting from the 50 yd line into the 60 yd berm. Shooting in that bay has always been done from the tables or the railroad ties. None of this makes any sense. The rules are not only drilled into the members at the briefing but are posted on each bay.

There are others I can list but for now there is one final thing. I was told that a member complained to another member who told an officer that he felt like he was always being watched. The answer to that is yes you are. I try to watch as much as I can. Larry walks the range for exercise and he also watches. It is the duty of every member to help police the range, we should all be watching for safety reasons, for making sure that eye and ear protection is worn, that gun handling and other safety rules are being observed, and that badges are worn. The only reason I can see that someone would be not want to be watched is that they are going to do something they shouldn't be doing. Like all the things I have mentioned above. I remind everybody. MCRC is one wayward bullet away from being closed.
