NCOWS uses rules similar to SASS Cowboy matches, although NCOWS pays greater attention to historical accuracy concerning our guns, clothing and equipment. We shoot in 2, 3 and 4-gun classes. Generally, any pre-1900 pistol, rifle in pistol caliber, and/or shotgun may be used. These can be originals in serviceable condition or reproductions. Additionally, we shoot smokeless and black powder. There is no overall winner in NCOWS matches; each class is judged independently. Come for the coffee, stay for the fun.
