I have placed a gong in the left corner of the rimfire bay. This is a study to decide the feasibility of putting some steel on bays that have very stable berms. We will see how this is received and if it can be accomplished safely. I will present findings to the executive committee in a month or so to determine if it can be done elsewhere.

We have also decided to try adding a second range briefing to help new members that have a problem getting to a Saturday briefing. NRA Pistol Instructor special course package: NRA Basic Instructor Training, NRA Pistol Instructor special course package on June 29-30, 2019.
